- Applications will be processed on a first-come, first-served basis.
- Only 56 (fifty-six) art vendors and 3 (three) food vendor spaces will be allowed.
- **All vendors are recommended to have general liability policy of Insurance showing on-site coverage.**
- Checks or money orders should be made payable to **Greater Good, Inc.**
- Application packages received without payment, Social Security, tax-exempt number or Federal tax ID number and a self-addressed envelope will not be considered.
- No setup before Thursday, March 5th at 3:00pm or dark on that day will be allowed.
- Setup must be completed before 3:00pm on Friday, March 6th
- No breakdowns before 4:00 pm Sunday March 8th
- Refunds are only given in case of medical emergencies. Requests must be accompanied by proof of medical emergency.
- Quartz halogen spotlights should be **limited to one** per booth. Please use twinkle lights or fluorescent bulbs. Only 14-gauge extension cords will be allowed.
- If vendor does not carry liability insurance, a vendor waiver must be signed before being approved for the festival.
- **Food Vendors**, please be specific on what you need for your space, i.e. 220,110 outlets. Please draw a diagram for space needed. After accepted by festival, please have your insurance agent send a copy of your certificate to us ASAP or sign Waiver releasing Greater Good Inc from responsibility for any damage or theft of your goods while participating in the Festival. **If not received by February 28<sup>th</sup>, 2009, we reserve the right to give your space to another vendor.**

You will be notified by phone or via e-mail of your application approval. Upon acceptance, your check or money will be deposited. If your application is not approved, your fee will be returned through your self-addressed envelope.
